### Notes:

- (1) The fees listed above are the statutory fees payable. **It is stressed that the figures do not include any charges for extras such as music (e.g. organist, choir), bells, and flowers, which are fixed by the Parochial Church Council.**
- (2) The fee for a marriage certificate is fixed by the Registrar General. It may be increased from 1 April 2010.
- (3) If a cemetery or cremation authority has itself fixed different charges for the minister's services in a cemetery or crematorium such charges will take precedence over those specified here.
- (4) 'Monument', here, is a technical term and includes, for example, a gravestone or headstone.
